RESERVATIONS

- Booking is available at <http://www.tradewindschedule.com> or through our Flight Coordination Department. Please send flight requests in writing so that there is no confusion.
- Ticket value is non-refundable.
- Pricing is subject to change at any time.
- All tickets purchased in 2012 will convert to dollar value at the next ticket book sale or December 31, 2012. Remaining dollar value may be used towards the purchase of new tickets at the prevailing rate.
- Bookings made beyond available credit will be charged to the credit card listed above at the current prevailing single-seat price.

FLIGHT

- Aircraft boarding will take place 15 minutes prior to scheduled departure. Please be prompt as we are not able to hold the flight.
- Cancellation within 48 hours of departure time will result in a forfeited ticket.
- Within 48 hours of departure time, changes may be made to flights on the same weekend in the same direction and when space is available.
- Missed flights may be rescheduled for the same weekend in the same direction and when space is available. Otherwise the ticket is forfeited.
- On this route Tradewind operates Pilatus PC12s and Cessna Grand Caravans which are eight passenger single-engine turbo prop aircraft. Tradewind reserves the right to substitute aircraft if necessary.
- Baggage allowance is 50lbs per person. Baggage exceeding this limit may not travel on the flight. Best efforts will be made to accommodate the baggage on a future flight but we cannot guarantee availability. Large, hard-sided or oversized items may not fit. All luggage must fit through the Caravan cargo compartment opening which is 15" X 28" (38 X 71 centimeters).
- Pets in carriers are always welcome. Outside of a carrier, pets are limited to one family per flight and pets in excess of 100lbs require the purchase of a seat. Please provide pet name and weight at the time of booking.
- In certain limited circumstances, pursuant to federal regulations and/or safety, our aircraft will not be able to depart from, or land at our destination. The decision to divert to another airport will be made by the Captain and will be made in the interest of safety. Passengers are responsible for any costs associated with alternative travel arrangements made necessary by the diversion.
